

Good Production Practices

Part 5 of the Cannabis Regulations mandates that Licensed Producers ensure the cleanliness of the premises and equipment. Having effective cleaning, sanitation and pre-operational Inspection procedures can minimize the risk of contamination of your product, ingredients, processing aids, packaging materials, and product contact surfaces.

The three-step cleaning sanitation process is an effective approach to apply:

- **Step 1.** Clean the equipment with an appropriate cleaning solution (i.e. a food safe degreaser).
- Step 2. Rinse the cleaning solution off equipment surfaces.
- **Step 3.** If cleaning solution residue remains, perform an additional rinse and then wipe the surface with a disinfectant, if no food contact, or a food contact sanitizer.
